Subject: Guidelines for conducting National Teachers' Eligibility Test (NTET-2025) by National Commission for Indian System of Medicine (NCISM).

Sir/Madam,

In accordance with the provisions of Clause (8) of National Commission for Indian System of Medicine (National Examinations for Indian System of Medicine) Regulations, 2023 vide notification dated 20th December 2023 laid down the minimum qualifications for a person to be eligible for appointment as Assistant Professor, Associate Professor and Professor in Indian System of Medicine Institutions. It had been inter alia provided that one of the essential qualifications for a person to be eligible for appointment as Assistant Professor, Associate Professor and Professor for first time in any of the colleges referred to in clause (1), (2) and (3) of section 17 of The National Commission For Indian System Of Medicine Act, 2020 is that he/she should qualify the National Teachers' Eligibility Test (NTET) which will be conducted by NCISM designated authority in accordance with the Guidelines framed by the NCISM.

In this regard, a preliminary information brochure is being attached with this communication. This may be brought to the knowledge of all the concerned.
