Develop the institution's vision document, outlining short-term and long-term goals, and monitor its implementation to ensure progress toward strategic objectives.

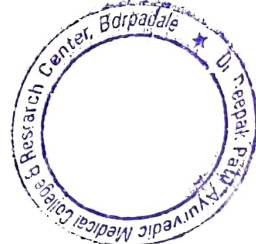
5.8. Academic Audit:

A clear and actionable plan for the institution's growth and development, as outlined in the vision document, ensuring sustainable success.

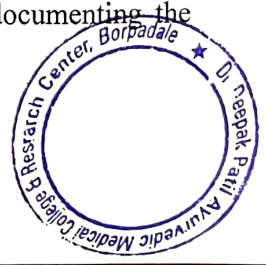
8. Regular Academic Audits:

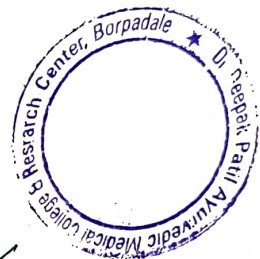


