### **5. Documentation:**

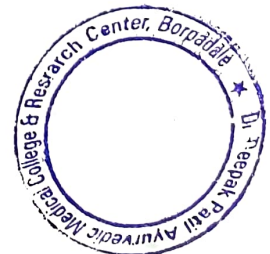


